

The York County Board of Commissioners, ex-officio the York County Board of Equalization, met October 18, 2011 at 9:30 a.m. as per notice in the York News Times on October 13, 2011, with Chairman, Kurt Bulgrin presiding with Pat Bredenkamp, Bill Bamesberger, Paul Buller and Tom Shellington. Also present at the meeting was Melanie Wilkinson, correspondent for the York News Times; Brenda Scavo, County Treasurer; Ann Charlton, Count Assessor and Orval Stahr, Zoning Administrator.
