

2026 Elections - York County Political Subdivisions

UPDATED 3/23/2026

Candidate filing begins Monday, January 5, 2026.

Primary election filing deadlines: Incumbents is February 17, 2026 Non-incumbents is March 2, 2026
***General election filing deadlines:** Incumbents is July 15, 2026 Non-incumbents is August 3, 2026

Some races may not appear on the primary election ballot if the number of candidates filing for office did not exceed twice the number of vacancies. For example, a "Vote for one" office with one or two candidates will not appear on the primary election ballot. However, if three candidates are running for a "Vote for one" office, all three will be on the primary ballot because there are more than two times the number of candidates than vacancies. The Election Commissioner shall place the names of such automatically nominated candidates on the general election ballot as provided.

*General election deadline only applicable to village board filings.
