

## Notice of Primary Election

Notice is hereby given that on Tuesday, May 12, 2026, at the usual polling places in the election precincts of York County, Nebraska, an election will be held. The polls will open at 8:00 a.m. CT and close at 8:00 p.m. CT. Said election will be for nominating candidates to various offices. **Per state statute 32-811(1), some races will not appear on the Primary ballot if the number of candidates filing for office did not exceed twice the number of vacancies; these candidates (marked with an asterisk) are declared nominated without opposition and will advance to the November 3<sup>rd</sup> General Election**, when candidates (for township officers, village boards, reclamation district boards, county weed district boards, public power district boards grossing under \$40 million, Class II schools, and educational service unit board members) may be elected. Unless labeled otherwise, term length for office is four years.

**SPECIAL ISSUE**

“Shall the York County Historical Association be authorized to increase its tax levy to a rate not to exceed 0.000616, which levy would generate approximately \$30,000 annually based on the current certified taxable valuation, for the purpose of funding the operation, preservation, and programming of the York County Historical Association?”

(This would be an approximate increase of \$0.62 per year per \$100,000 of taxable property value.)”
